**Subject: Policy on refraining from giving and receiving gifts Gifts or other benefits
(No gift Policy)**

In accordance with the Cabinet resolution on December 8, 2020 approved the national action plan for preventing and suppressing corruption and misconduct. (revised edition) with a drive to carry out important reform activities (Big Rock). Reform activity number 4: Develop the Thai bureaucracy to be transparent and free of benefits. Goal No. 1, Section 1.1, "Have every government agency declare itself to be an agency where all government officials do not accept gifts and all kinds of gifts in the performance of their duties (No Gift Policy) in order to strengthen values to create save and create the right attitude .The heads of government agencies and commanders must act as good examples. develop consciousness Attitude and behavior of subordinates As well as instructing government officials to behave correctly regarding giving or receiving gifts, or any other benefits according with relevant laws and regulations In addition, Surat Thani Province has given importance to preventing corruption and misconduct according to government policy and mission. "The Ministry of the Interior is clean and clear." continuously in order to instill values in working with honesty and integrity. and the participation of executives and in accordance with the principles of good governance. Do not accept gifts of any kind while performing your dutiesand strengthen the value of saving according to the philosophy of sufficiency economy. and is an internal measure to prevent corruption Therefore, it has announced its intention of "honesty, transparency, Surat Thani Province" and "no gift policy"

In this regard, to drive reform activities according to the national reform plan above. This is in accordance with the Cabinet's orders create transparency within the agency Create values in performing duties and should practice it as a culture of honesty .Krut Subdistrict Municipality therefore announces a policy for all executives, employees, officials, and personnel under its jurisdiction. Do not accept gifts and all kinds of gifts from performing duties (No Gift Policy) Whether before, at or after every official occasion, the festival and special occasions will result in corruption and misconduct both now and in the future on all festivals and special occasions. Except in cases of unavoidable necessity,

the rules for accepting gifts or gifts must be followed. and any other benefits According to the regulations of the Office of the Prime Minister regarding giving or receiving gifts by government officials, B.E. 2 0 0 1 Accompanying the announcement of the National Anti-Corruption Commission regarding the criteria for receiving property or other benefits through the ethics of government officials, B.E. 2020, to be adhered to as a guideline as follows:

1. Do not ask about giving or receiving gifts, souvenirs, presents, or any other benefits.

2. Not giving or not receiving Property or any other benefits from a person or other agencies Due to the performance of duties In cases where it is necessary to give or receive gifts, property, or any other benefits By tradition or maintaining good relations The use of greeting cards should be encouraged. Signing the blessing book Congratulation card or wishing through social media Instead of giving and receiving gifts on important occasions Make sure that the price or value of receiving or giving is From each person on each occasion, not more than 3,000 baht. Be careful of underestimating the value of gifts or other benefits. Also for the benefit of creating an attitude of saving.

3. Not consent or connivance. to an individual or family member Give or receive gifts or any other benefits to those involved in the work.

4. Welcoming and acknowledging supervisors or executives. Provide appropriate welcome, emphasizing simple, economical, and appropriate certification in accordance with relevant regulations. and prevent encroachment Solicitation of subordinates unnecessarily
